### Course Description

Explore innovative, life-enhancing programs and strategies that promote optimal animal health and welfare, ideal community and personnel involvement, and organizational success of animal welfare organizations.

### Course Content

Life-enhancing programs and strategies in animal welfare organizations may occur at various stages of the animal shelter experience. These programs and strategies occur prior to an animal's entry to the shelter, during their shelter stay and following their exit from the shelter. A holistic exploration of the programs and strategies that address the needs of the animals, the organization, and the staff and community members associated with the organization will be discussed as follows:

Pre-Shelter Programming: Organizational Structure, Function & Regulation, Field Services, Community Based Initiatives, Community Cat Management, Managed Admissions

Shelter Programming: Human and Animal Welfare, Population Management, Animal Medical and Behavioral Care, Foster and Transport Programming, Euthanasia Considerations

Post-Shelter Programming: Adoption Programming

- Identify the structure, function and purpose of an animal welfare organization.
- Recognize the impact of legislation, policies and procedures on life-saving strategies.

- Resource regional (local, county, state) laws and regulations affecting shelter animal care and welfare.
- Identify diversion strategies in animal welfare organizations.
- Appreciate the dynamic of managed admissions.
- Review successful sheltering programs that augment animal health and welfare.
- Apply the Five Freedoms as it pertains to human and animal welfare.
- Recognize the impact of FAS on animal welfare in animal welfare organizations.
- Describe the impact of intake programming and its effect on animal health and welfare.
- Critique animal shelter programs on life-enhancing measures.
- Communicate life-enhancing strategies with administrators, board members and community members.
- Recommend shelter programming or strategies that lead to life-enhancing measures.
- Complete Fear Free Shelters Certification.
