Course Description

Students design and present to a live online audience a culminating project and e-portfolio that demonstrates their academic achievement and ability to use the knowledge and skills gained while completing the online MS Veterinary Medical Sciences, Concentration in Shelter Medicine.

Course Content

This is the culminating experience of the MS Veterinary Medical Sciences Concentration in Shelter Medicine degree and serves as the exit examination to qualify for the degree. Students must enroll for a minimum of 1 credit of this course during their final semester, but may enroll in up to 3 credits, with faculty approval, depending on the amount of work required to complete their chosen project. During the pursuit of the MS degree, students will select a project to pursue that demonstrates application of the knowledge and skills they achieve while earning the degree. Projects must include a literature search and review of all pertinent scientific studies related to the topic; projects do not need to conduct original research that is intended to be published but still might require IRB and/or IACUC approval depending on the project selected. A project proposal must be presented to the course faculty for approval prior to beginning work and students are expected to do regular check-ins with a faculty mentor as they complete the project. Students also create and share an online e-portfolio that displays work they submitted during their academic studies, includes literature reviewed for the project, and demonstrates achievement worthy of earning the degree. In their final semester, students work with their faculty to create a professional presentation of their project to present before a live online audience that consists of their peers, faculty members, and invited guests. The audience leaves anonymous formal peer feedback for the student that is incorporated into the final grade for the project.

Course Prerequisites

Students must have an approved Capstone Project Proposal that is mostly completed prior to enrolling in this course during their final semester. The presentation to a live audience serves as the exit exam needed to qualify for graduation.

Co-Requisites

Students must enroll for a minimum of 1 credit of this course during their final semester. In addition,

UF requires students in their final semester to enroll in a minimum of 3 credits if graduating in a Fall or Spring term, and 2 credits if graduating in a Summer term. This course is variable credit to assist with meeting that requirement. Students taking this course for more than one credit will be required to meet more often with the instructor, up to twice weekly via Zoom check ins.

Course Objectives

By the end of this course, students will be able to:

- 1. Develop and complete a project that demonstrates an ability to apply knowledge and skills gained while completing the academic requirements of the MS Concentration in Shelter Medicine.
- 2. Present project to an online audience of faculty members, fellow graduate students, and invited guests and take questions and comments from the audience.
- 3. Create and share an online e-portfolio that documents academic achievement during the pursuit of the MS Veterinary Medical Sciences degree and includes all citations used for development of the Capstone Project
- 4. Demonstrate proficiency with delivering an effective oral presentation including: voice modulation, speed and coherence of presentation, quality of slides, ability to handle questions, ability to effectively use time, ability to use technology.
- 5. Demonstrate proficiency with core professional competencies including: communication skills, collaboration skills, management/leadership skills, lifelong-learning related to scholarship and research, diversity and multicultural awareness, critical-thinking skills, and/or ability to adapt to changing environments.
