Course Description

Apply principles of good writing and strong visual layouts for transforming academic research into public documents that can be shared during your Capstone Project Presentation as well as at conferences, meetings, or the animal shelter workplace. Understand how to read a scientific paper.

Course Content

This online course fulfills the "Writing in the Sciences" requirement needed to complete the MS Concentration in Shelter Medicine. It is best taken after your advisor has approved your Capstone Project Proposal so you can begin working on your presentation. In this course you will review the mechanics of strong writing, crafting clear messages, and delivering visually appealing presentation materials for an online audience. You will also review what goes into writing a scientific paper and how to review a scientific study. With individual coaching from your instructors and classmates, you will develop a scientific poster, PowerPoint presentation slides, educational handouts, and a recorded presentation that you can use when you present your Capstone Project during your final semester of the MS degree, at scientific conferences, or within an animal shelter for educational purposes. You will also participate in an Online Journal Club.

Course Objectives

By the end of this online course, students will be able to:

- Identify the various audiences with whom they wish to communicate.
- Craft the message they wish to deliver verbally and visually.
- Express research in a "science narrative" style appropriate to academics.
- Design a poster, PowerPoint presentation, and educational handouts that effectively communicate a controlled message.
- Record a potential capstone-presentation specific version of their research that will be further refined and delivered in the final semester prior to graduation.
- Review at least four scientific papers to identify journal type, impact factor, study methodology, study type, and rate confidence in the evidence presented.

Grade Changes: Grades will be changed only when a grading error has been made. If you think an error has been made, you should email the instructor as soon as possible. Your entire assignment will then be re-graded.

Incomplete grades: Under special circumstances, if a student is unable to finish a course before the end of the semester we may be able to assign an incomplete grade. An incomplete grade is a non-punitive grade assigned at the discretion of the course instructor. In this course an incomplete grade may be assigned if 1/3rd or more of the course assignments have been completed and if the student has remained in communication with TA's and instructors throughout the course, or has made an effort to request an incomplete grade.
